Official Rules

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. 1. **ELIGIBILITY:** The Bob Evans Farms® Back-to-School Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia, who are eighteen (18) years of age or older as of time/date of entry. Employees, officers and directors of Bob Evans Farms, Inc (“Sponsor”), Carmichael Lynch Relate, MorganMyers, Realtime Media LLC (“Administrator”) and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies (collectively, the “Sweepstakes Parties”), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. 2. **TIMING:** The Sweepstakes begins at or about 7:00 a.m. Central Time (“CT”) on July 29, 2026 and ends at 11:59 p.m. CT on August 26, 2026 (the “Sweepstakes Period”). The designated computer clock of the Administrator is the official time-keeping device for the Sweepstakes.
3. **HOW TO ENTER:** To participate and enter this Sweepstakes, visit Instagram.com or download the Instagram application and sign up for an Instagram account (“Instagram Account”) if you do not already have one. Creating an Instagram Account is free. By submitting your information and creating an Instagram Account, you will be required to agree to Instagram’s terms of service and privacy policy. If you do not agree to Instagram’s terms of service and privacy notice, you cannot create an Instagram Account or participate in this Sweepstakes via this method.

Once you have an Instagram Account, log in and become a follower of @BobEvansGrocery (the “Instagram Handle”) and locate the Sponsor-designated post promoting this Sweepstakes (the “Instagram Post”). To enter, during the Sweepstakes Period, you must: (i) follow the Instagram Handle; (ii) like the Instagram Post; and (iii) comment on the Instagram Post with your favorite back-to-school season hack, tip, or trick (the “Instagram Entry”). Your Instagram Account must remain public during the Sweepstakes Period and through winner verification in order for Sponsor to verify your Instagram Entry. Instagram Entries not received by Sponsor will not be entered into the Sweepstakes.

By taking the steps above, you are confirming your acceptance of and agreement to these Official Rules. Upon successfully completing all required steps, you will receive one (1) entry into the Sweepstakes, subject to the limit below.

The Sweepstakes Parties are not responsible for technical difficulties of any kind, or for false, incorrect, changed, incomplete, or illegible contact information.

LIMIT: One (1) entry per person during the Sweepstakes Period. - Is obscene or offensive; endorses any form of hate or hate group;
- Defames, misrepresents or contains disparaging remarks about other people or companies;
- Contains trademarks owned by others (other than the Sponsor), without permission;
- Contains any personal identification such as personal names, email addresses or street addresses;
- Contains any individual other than you and/or any materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead;
- Is not written in the English language.
- Communicates messages or images inconsistent with the positive images and/or good will to which Sponsor wishes to associate; and/or violates any law.

5. SWEEPSTAKES DRAWING: On or about September 4, 2026, fifty (50) potential winners will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The random drawing will be conducted by Sponsor or Administrator, whose decisions are final and binding in all matters relating to the Sweepstakes.

6. ODDS: Odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period.

7. WINNER NOTIFICATION/PRIZE CLAIMING: Potential winners will be notified via direct message on Instagram using the Instagram Account associated with the winning Entry in a commercially reasonable time after the drawing. Each entrant must maintain a public Instagram Account and continue following @BobEvansGrocery through winner verification and prize fulfillment. The Sweepstakes Parties are not responsible for and shall not be liable for false, incorrect, changed, incomplete, or illegible contact information, or for electronic communications that are undeliverable

for any reason, including as a result of any form of active or passive filtering of any kind or insufficient space in an entrant's account to receive messages. The Sweepstakes Parties are not responsible for late, lost, intercepted, misdirected, or unsuccessful efforts to notify a potential winner. Notification is deemed to have occurred immediately upon the sending of the direct message. GOVERNING LAW AND LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Ohio, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

- 14. DISPUTE RESOLUTION:** The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of Ohio, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action

or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of Ohio. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Ohio. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

- 15. ENTRY INFORMATION AND SWEEPSTAKES COMMUNICATIONS:** As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules. - 16. MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
